

TERMS AND CONDITIONS OF ENTRY

Competition and promoter:

2. The name of the competition is 'June Genius 2019'

Who may enter:

3. Entry to the competition is open to all members of the general public in Australia.

How to enter:

4. Information on how to enter forms part of the terms and conditions of entry. Entry into the competition is deemed acceptance of these terms and conditions.
5. Entry to the competition is free.
6. Up to 30 entries is permitted per person, are acceptable.
7. Competition Period
